YEAR 6 CANBERRA EXCURSION: INFORMATION UPDATE

The Year 6 Canberra trip is fast approaching!

Day back-pack

Students are to pack a bag for the bus which includes a refillable water bottle, school hat, lunch and snacks for the first day. Please don't give children lollies or gum. Students should bring something to keep them warm and/or comfortable on the bus such as a jumper.

Money

During the trip, there will be opportunities to buy souvenirs (eg Questacon gift shop). If you would like to give your child some money, we recommend \$20-\$50 (nothing more). To keep money safe, parents will hand spending money to the coordinating teachers at the beginning of the trip. Teachers will give each student their spending money when spending opportunities arise.

Mobile phones and technology

Mobile phones and other forms of technology are not permitted on the excursion.

If you need to contact your child during the excursion, you are to call the school who will get in contact with the teachers. Parents of students attending the trip will be given an after hours contact number on the day of the trip.

Cameras are not necessary as staff will be taking photographs regularly and posting to FB.







Behaviour

While on excursion and in all venues, students are expected to follow our School PBL values: Be Safe, Be Respectful, Be Friendly and Do Your Personal Best.

A behaviour agreement will be sent out just before the trip.

In Stage 3, our focus areas are particularly important. Those messages include:

- Follow instructions: First time, every time
- Use respectful language
- Reject violence
- Challenge bullying

School Uniform Expectations

Taking students to multiple venues to give them a range of experiences requires a great deal of organisation and planning. To assist with the smooth running of the excursion and transitions between venues, students are required to wear their school uniform each day. They will change into civvies once we return to the hotel.

More details regarding medication requirements will also be provided at that time.

MEDICAL AND CONSENT FORM: Year 6 Canberra Excursion – Why do we need this?

The information provided on is being obtained for the purpose of ascertaining relevant medical information, requirements and other health care related needs about your child who is currently enrolled at the school and who may participate in school excursions, sporting activities or other educational or school activities conducted by or in conjunction with Tanilba Bay Public School.

It will be used by officers of the NSW Department of Education and Training to assist planning, to support students, and to minimise risks when conducting school excursions, sporting or other school activities.

Other persons or agencies that may be provided with this information include, but are not limited to, volunteers and members of external organisations who join with the school or are otherwise involved in the planning or delivery of the excursion, sporting or other school activity; and persons that may be called upon to provide health care treatment or other assistance during or as a consequence of such excursions or activities.

Provision of this information is not required by law. However, a failure to provide the information may mean that your child can not participate in a particular excursion or school activity. In such circumstances the school will make available a sound alternative educational experience.

Provision of this information will significantly assist the school in planning a safer educational activity. It will be stored securely. If you have any concerns about provision of this information, please contact the school principal to discuss further.

You may correct any personal information provided at any time by contacting the school office.

In order for our supervising teachers to be fully equipped to ensure your son/daughter is afforded the utmost attention and consideration at all times, I ask you to supply the following information. It means that we have the most up to date information at the time of the excursion. All information supplied shall be treated as confidential.
